There was 275 applications in total that was approved in full which totaled 13,873.5 acres. There was 452 applications approved in part. 29,816.5 applied and 26,156.8 acres were approved. There were 2 late application in which zero acres were approved. 9 applications withdrawn, 6 applications with 795 acres were outside of the FOD therefore not eligible. There was 8 applications with less than 4 acres totaling 31.2 acres not eligible. There were 11 applications with 973.6 acres of in-eligible districts. Giving a total of 772 applications received with 45,940.4 acres applied for and 40,030.3 approved acres.

The small acre program consisted of 8 applications. In the original handouts presented to the board, Malin and Shasta View were reversed in applicant info column. The corrected version is below.

Discuss and Approve Per Acre Rate for 2022 Claims

The board discussed funding. Moss Driscoll stated that the is no budget of 2023 but DRA should for to \$20 million for 2023. Mike McKoen asks Moss what will happen to the \$1.8 million that the DRA will have remaining from this year, should they try to spend it? It was stated that even if you pay everyone \$50 more an acre, there is not enough money. Mike interjected that \$450 does not keep anyone whole. Moss agreed, he stated that the funds will be de-obligated and goes back to the Regional fund as the contract is ending. He stated that hopefully there is some goodwill by Reclamation to recommit those funds back to the DRA in 2023. Mike Neuman stated that based on the 2019 figures, there is only \$6.9 million available. If reclamation can get the fiscal year changed to a physical year then there is more funds available.
